



ORDER

In terms of Section 14(1) of the NCTE Act, 1993 **Nagammai Teacher Training Institute, Periyar Centenary Educational Complex, Periyar Nagar, Tiruchirappalli - 620 021, Tamilnadu** had submitted an application to the Southern Regional Committee of NCTE for grant of recognition for **Elementary** Course of **two years** from the academic session **2002-03** with an additional intake of **40** students.

2. On scrutiny of the application submitted by the institution, the documents attached therewith and the input received from the visiting team, the Committee has noted the following:

- a) The institution has acquired the land for setting up the teacher education institution.
- b) The institution has constructed the building for conducting the course on the above mentioned land.
- c) The institution has selected the Principal and **Nine** teachers for the said course, which is approved by the Director, DTERT, Chennai.


3. Now, therefore, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition to **Nagammai Teacher Training Institute, Periyar Centenary Educational Complex, Periyar Nagar, Tiruchirappalli - 620 021, Tamilnadu** of **two years** from the academic session **2002-2003** with an annual intake of **80** students which includes the existing intake of 40 and an additional intake of 40, subject to fulfillment of the following.

- a) The institution will ensure that **Ten** faculty members are in position for an intake of **80** students before commencement of the course and a report to this effect shall be sent to the Committee immediately and in any case not later than one month from the date of commencement of the course.
- b) The institution shall, within one month of the receipt of recognition order, convert the Endowment fund account into a joint account to be operated along with an official of the Regional Committee.
- c) The institution shall, within one month of the receipt of recognition order, create the Reserve fund account equivalent to three months salary of the staff (teaching and non-teaching).

- 4) The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations.
4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like the State Government etc.
5. The institution shall submit to the Regional Committee a Performance Appraisal Report at the end of each academic year along with a copy of the approval of the Directorate of Teacher Education Research and Training (DTERT) to the appointment of faculty members, and the statement of annual accounts duly audited by a Chartered Accountant.
6. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued thereunder, the Regional Committee may withdraw the recognition under the Provisions of Section 17(1) of the NCTE Act.


